Important information for travelling to United Kingdom

All EU citizens (including children and babies) travelling to/from the UK must hold a valid passport valid beyond the date of return. All UK citizens and non-EU citizens (including children and babies) travelling to/from the Netherlands must hold a valid passport valid for 3 months after the date of return.

GENERAL INFORMATION

Please note: It is not compulsory to bring this e-ticket with you to the port but you will need to be able to quote the booking reference that is included at the top right of this e-ticket when checking-in.

Irish and British citizens travelling on our Irish Sea routes do not need a passport to travel to Britain or Ireland but are advised to take a form of identity. A valid passport, photographic driving license, International Student Card, government issued photo ID cards, health insurance/social security photographic cards, photographic bus/train pass or EU Citizen Identity Card will usually suffice. If you are travelling with children, a birth certificate will provide adequate proof of identity for your child to travel on our sailings.

Irish and British citizens travelling to Mainland Europe **must** bring a valid passport. Remember that the name on your passport must match the name on your booking otherwise you may not be able to travel and your insurance may be invalid. Other passport holders should check with the relevant embassy regarding passport and visa requirements.

A passport for all passengers (including children and infants) is required for all trips to Continental Europe. Your passport must be less than 10 years old and have at least 3 months validity following the date of your return travel. It is your responsibility to check and observe all the health and entry requirements applicable to your journey and you should always check the latest travel guidance from your government before you travel and the guidance provided by the relevant public authorities of your destination. You must ensure that you have all documentation needed to comply with the requirements of immigration, customs, health and other relevant regulations. We reserve the right to check and record details of such documentation and to refuse you permission to board if such documentation is not produced to our satisfaction. You will be required to reimburse us in full for any fines, repatriation or other removal costs, detention costs and all related expenses, which we may bear or incur by reason of your failure to produce such documentation to the relevant authorities.

EU Roaming Fees

Whilst roaming charges when travelling in EU countries ended on 15 June 2017, the EU roaming rules only apply when you are connected to terrestrial mobile networks. The EU binding price cap does not apply if you use your mobile phone onboard via the ferry's satellite connection and, therefore, the charges set by your network provider can be high.
